MESSAGE FROM THE PRÉSIDENT

This year's theme for Pro Week is "Present. Professional." At a time where needs are skyrocketing and the shortage of qualified workers continue, I witness every day your essential contribution and commitment to meeting the needs of students, teachers and the school organization, whether in support services, pedagogical services or administrative services.

Yet, there's no shortage of reasons to give up. We recently toured the province of Quebec, identifying several very worrying and sometimes dramatic situations.

HERE ARE A FEW OF THEM

- At CSS Marguerite-Bourgeoys alone, there are currently around 90 vacancies out of a total of just over 500 for professional staff;
- A SA (Student Advisor) in the Outaouais region told us that just over a third of the teachers she is supporting are unqualified. And she's not the only one;
- On the Côte-Nord, but also elsewhere, we're no longer able to attract and retain young professionals. Resignations and job postings are multiplying, while vacancies and openings created by retirements often remain unfilled;
- Especially in Montréal, where the housing stock is crumbling, the numerous engineers and architects are constantly losing the expertise of their colleagues who are leaving for better conditions;
- As the number of schools to be served multiplies, so do the needs of the students. Currently, there are between 600 and 1,000 vacancies for psychologists, psycho-educators and speech therapists alone.

Despite this, each and every one of you, against all odds, continues to offer high-quality "public" services, often at arm's length. Thankfully, you're still here... "always here, always ready and always pro." You're making us proud, but it's clear that in the medium and long term, this situation will become unbearable for many of us.

Unfortunately, the government doesn't seem to understand the extent of the problem.


Providing services outside the school, through the private sector, is not the way to ensure the successful future of our society. Naturally, the best support in a school environment is provided by all those who live and work there daily. Their solutions and interventions are tailored to meet the needs of our students, and as a result, they are suitable and effective.

Here are just a few of the themes that are dear to us that go beyond the salary offered. We are advocating for and proposing these issues to the government, the ministère de l'Éducation and our partners for greater efficiency, and that go beyond the salary offered.

- Review funding and intervention based on the students' real needs, rather than in terms of organization;
- Provide service thresholds;
- Set up a vacancy monitoring mechanism;
- Establish processes and funding for multidisciplinary teamwork;
- Greater flexibility and recognition in work organization;
- Enhancing the value of public professional services.

All our jobs are essential to student success, and they deserve more public recognition and commitment. FPPE is convinced of this.

BILL 23:

ANOTHER STRUCTURAL AND GOVERNANCE REFORM

Never has François Legault's government been as unpopular as it is currently amid the strength of the Front commun, the labour shortage, the public services collapsing, and the attempted reforms in health and education being denounced on all sides.

Bill 23, An Act to Amend the Education Act and to enact the Act respecting the Institut national d'excellence en éducation (PL 23) is part of this trend. Members of the parliament are currently studying this project, which is generating more mistrust than enthusiasm among all stakeholders in the school system.

More Powers for the Minister

In addition to creating a new Institut d'excellence en éducation (INEE) whose relevance and independence have yet to be proven, PL 23 aims to centralize more powers in the hands of the Minister. For example, the Minister has the right to challenge all decisions made by a school organization.

If adopted as presented, PL 23 will likely be challenged by English-language school boards, who successfully challenged Bill 40 (2020), which would have transformed school boards into school service centres. The Quebec government is currently appealing this decision.

Making Changes Without Analyzing Risks

PL 23 proposes legislative changes to facilitate the collection and use of data. While there is a consensus on the need to improve access to data in education, we must remain vigilant to maintain privacy regulations and consider the risks of discriminatory bias induced using specific data.

PL 23 also opens the door to broader access to complementary remote educational services. Various experiments are being conducted in the field, but to this date, there are no national guidelines or validated research findings. While not opposed, the FPPE (CSQ) urges caution. We believe that the best service is the one provided in the student's living and social environment.

What is the vision for education?

The 75-clause bill raises several issues, including the teaching staff continuing education. The FPPE (CSQ) is also concerned about the ministerial shift undertaken, in which improving the success rate becomes the only data that really seems to matter.

We're looking for a vision, a social project, a largescale action to promote student well-being, equity and inclusive education, but to no avail-PL 23 doesn't address the fundamental problems of the public school system.
